DESCRIPTION

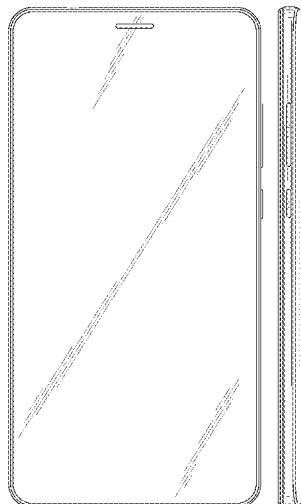
FIG. 1 is a front perspective view of a terminal device showing our new design;

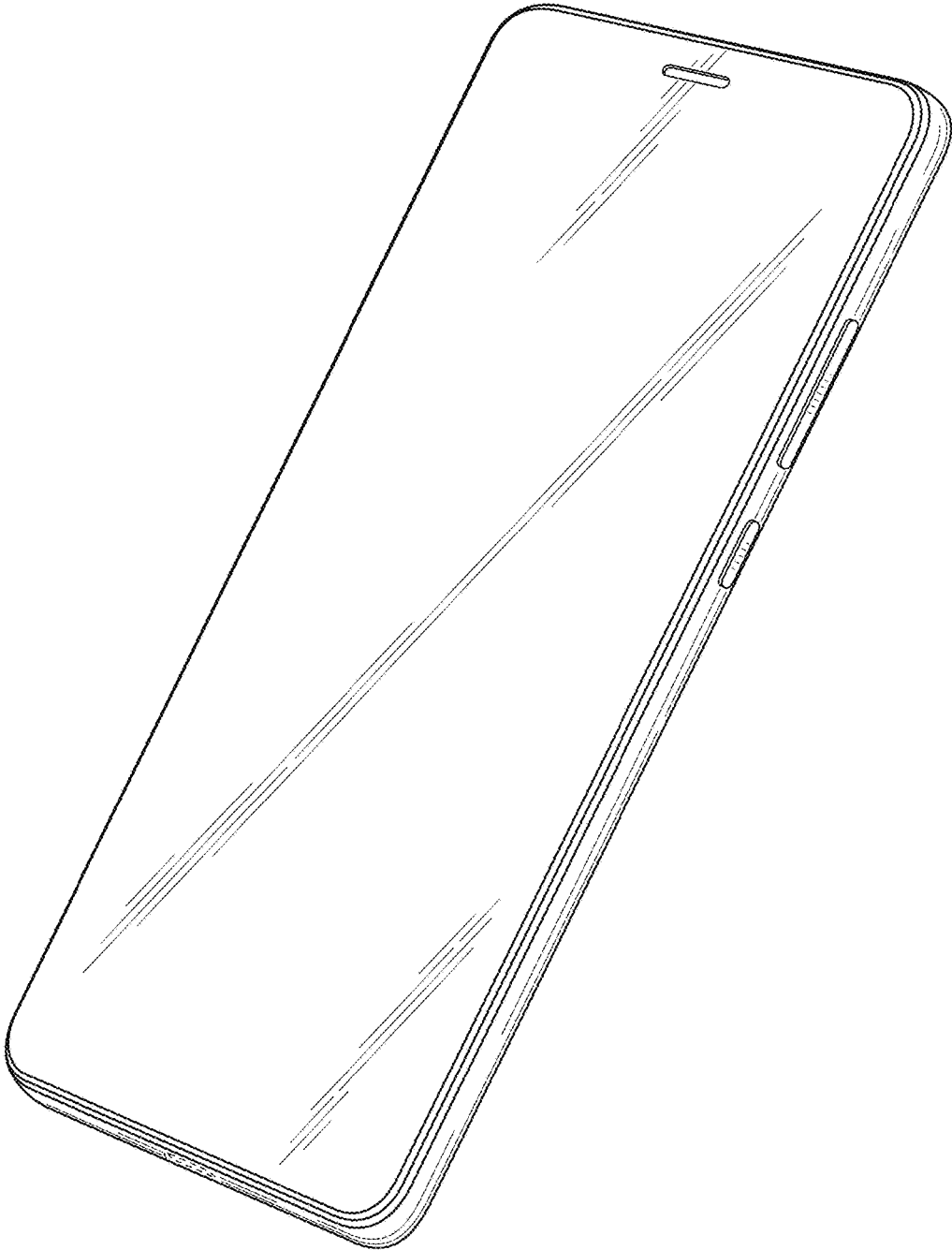

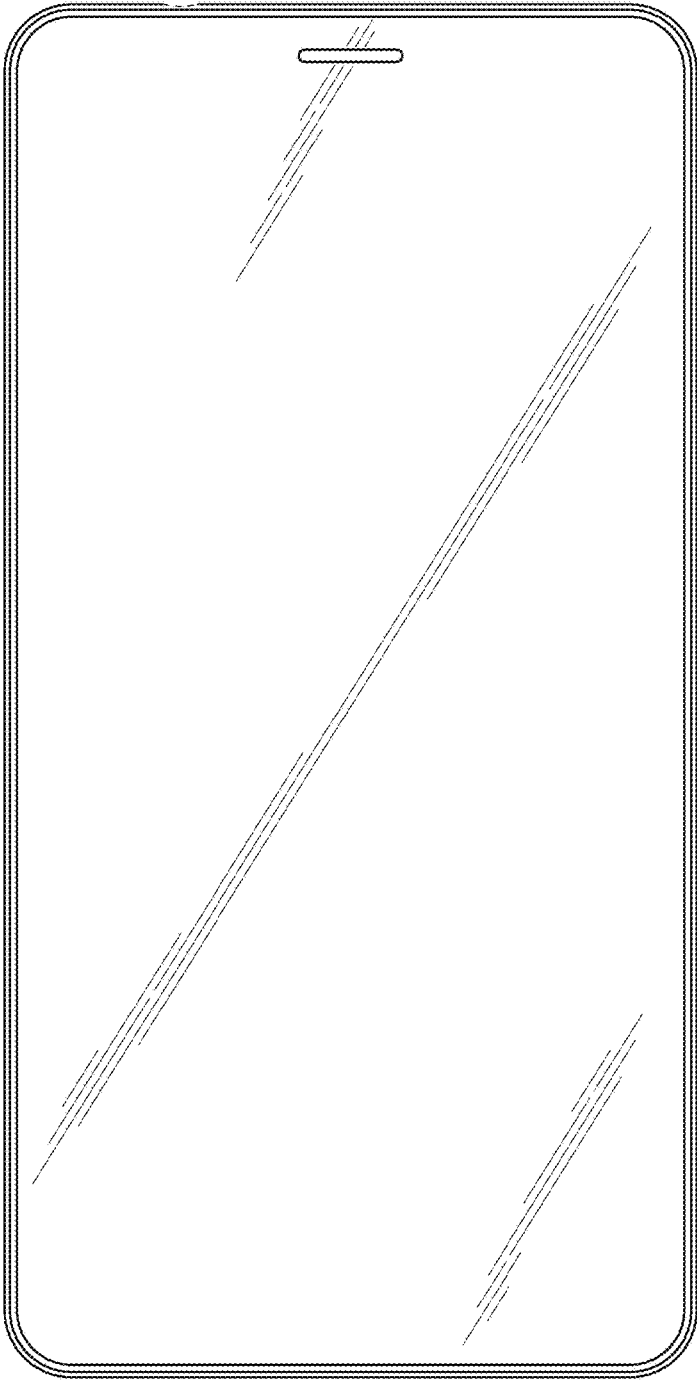

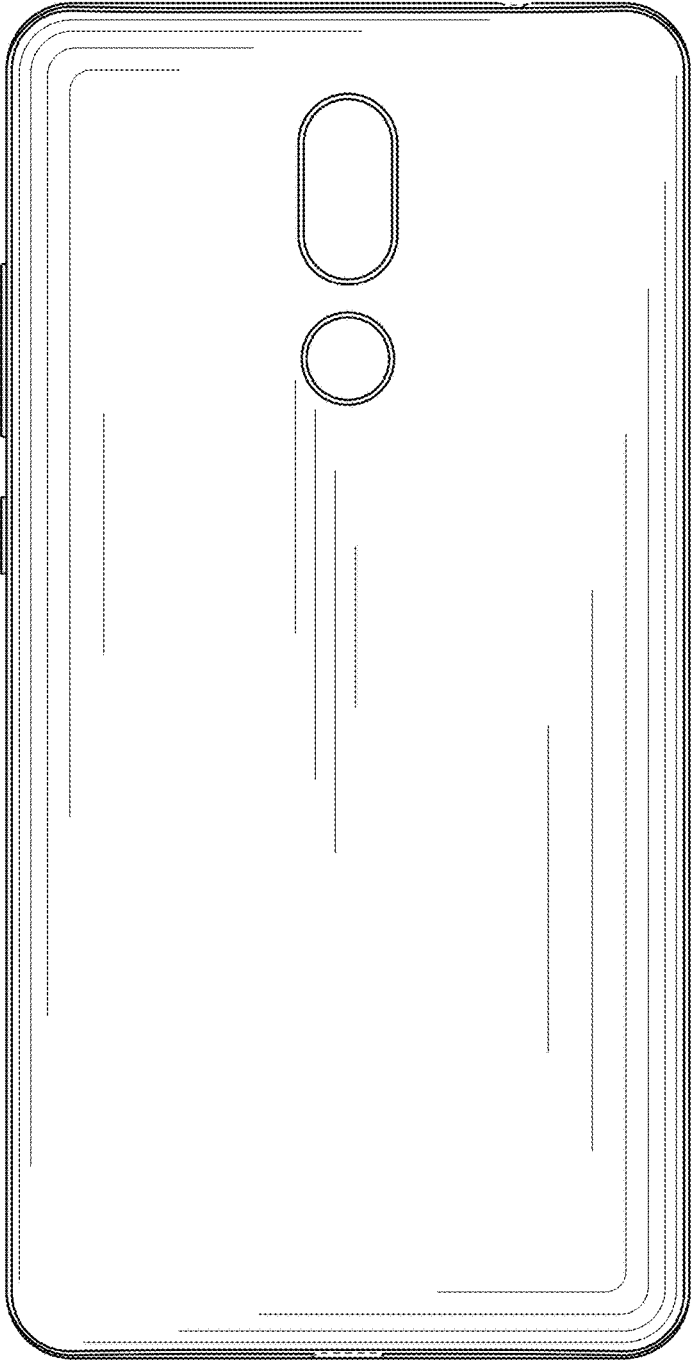

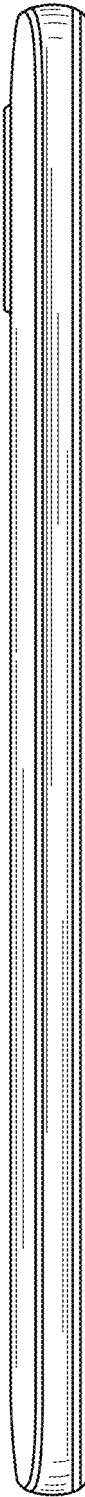

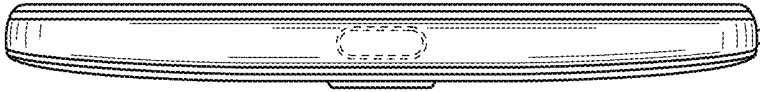

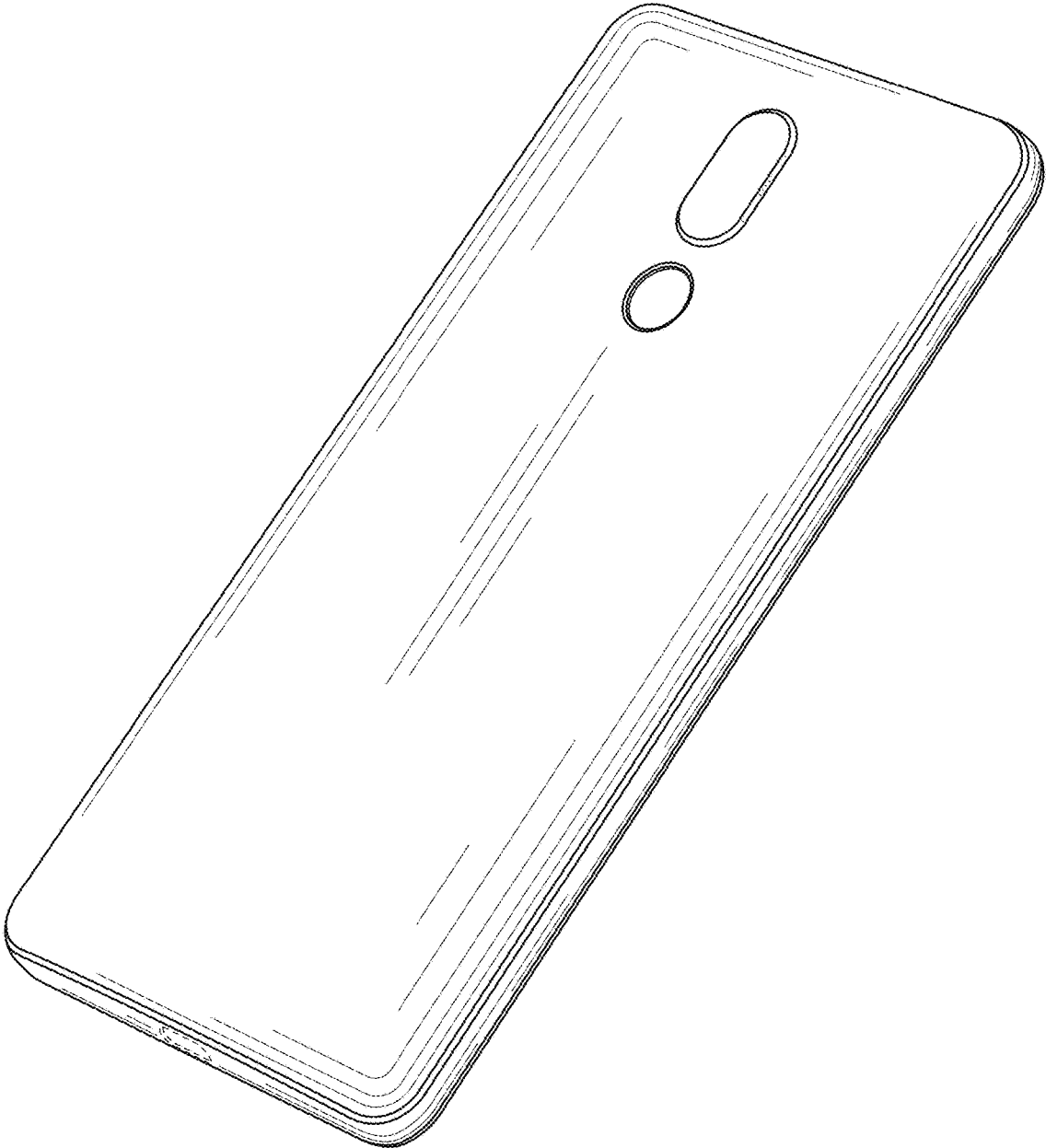
